MOTION by Rovazzi, seconded by Mowers to accept the Town Clerk's March 2019 report for \$724.50. Carried.

MOTION by Mowers, seconded by Bennett to accept Judge Stone's March 2019 report for \$60,532.43, of which \$46,225.52 is unidentified funds. Carried.

MOTION by Geloso, seconded by Mowers to accept Judge Engert's March 2019 report for \$1,117.00. Carried.

MOTION by Mowers, seconded by Brewer to approve payment for a GFIM bill for March for \$357.15. Carried.

Motion by Geloso, seconded by Mowers to pay bills as audited. Aye Brewer, Mowers, Bennett, Geloso. Nay Rovazzi (lack of funds in zoning B8010.4 due to legal fees). Carried.

Cemetery Funding – Town has issued checks to Dennison Corners Cemetery for \$500.00 and Ilion Cemetery for \$3000.00 as budgeted.

Library Funding -

Easter Egg Hunt – A check was issued to the Friends of German Flatts Town Park for \$400.00 for the Easter Egg Hunt given for the children of German Flatts.

Ilion Steele Creek SEQR – The Village of Ilion will be lead agency.

Drop-off – The drop-off will be May 18, 2019, 8-11 am at the Town Garage, Creek Road Mohawk.

Veterans' Flags – A check was issued to Valley Veterans Council for \$1,433.58 for flags to put on graves of deceased veterans as budgeted.

April Budget Adjustments – Moved \$57.00 to Zoning Contr. Expend B8010.4 from Youth Program, Contr. Expend B7310.4 to cover Codes' April cell phone bill of \$56.98. Special meeting is schedule for May 9, 2019 at 3:30 to open bids for lawn mower and to approve RAN resolution for Fulmer Creek High Bank Stabilization Project.

MOTION by Mowers, seconded by Brewer to accept standard work day and report resolution for Aiello, Hawkins, Jones, Manne and Steele. Carried.

MOTION by Rovazzi, seconded by Bennett to divide the \$400.00 Registrar of Vital Statistics wages between Jones Registrar and Madore Deputy Registrar at \$200.00 each. Carried.
