MOTION by Hendrix, seconded by Rovazzi to approve Judge Engert's March 2023 report for \$1,328.00. Brewer abstained. Carried.

OTHER REPORTS

HIGHWAY – Newtown reported last day of work for Wellington was April 17, 2023 and for Mark Kenyon it was April 26, 2023. Chad Francisco will stay on as part time seasonal, call as needed. Newtown received a Memorandum of Inter – Municipal Agreement between Jefferson-Lewis-Hamilton-Herkimer-Oneida BOCES and Town of German Flatts for Drug and Alcohol testing, for July 1, 2023 – June 30, 2024. This is a yearly agreement but Newtown wanted board to be aware of the new \$400.00 administration fee.

HIGHWAY 284 AGREEMENT -

MOTION by Hendrix, seconded by Brewer to approve agreement for the expenditure of highway moneys. Carried.

DOG CONTROL – Hawkins reported 2 dog calls in Mohawk and 1 dog call in Ilion. Hawkins also responded to a call only after receiving calls from the NY State Police and the Herkimer County Humane Society asking him to pick up the cat that was hit on Warren Road, and transport it to HCHS. The cat was euthanized. Mr. Schrader said Town will be responsible for bill.

HERKIMER COUNTY HUMANE SOCIETY AGREEMENT – Rovazzi contacted HCHS about adding wording on the new agreement to include having new adopted dogs license before the dog is released to their new owners. Per a phone conversation, Mr. Schrader was not in favor of this saying it was the DCO job to stop over to the shelter and get any information about the dogs being adopted out into his community. Said they are a 501(c)(3) not for profit and do not have the resources to do this Atty. Manne suggested, writing this wording into contract, initial it, sign contract and mail it back.

MOTION by Hendrix, seconded by Rovazzi to approve with changes suggested by Atty. Manne, the Agreement with HCHS. Carried.

CODES – Sweeney reported 7 permit have been issued this year, 2 have been closed and 2 are pending.

ARPA APRIL REPORT DUE – Rovazzi reported the majority of funds received for ARPA were spent on a new roof for the Town garage. Report is due at the end of the month. Will report next April for remaining funds.
