ROVAZZI was in contact with Andy Steele of the Mohawk Municipal Commission, about the needs of a hydrant on Warren Road, which would be located outside of the Village, due to rusty water backup. The hydrant would need to be flushed to decrease this backup.

MOTION by Brewer, seconded by Rovazzi to pay MMC to install hydrant on Warren Road. Carried.
