MOTION by Brewer, seconded by Mowers to have Atty. Manne review contract with Ford Motor Company on wording of contract. Is it a lease or purchase of truck? Carried.

MOTION by Brewer, seconded by Mowers to have Atty. Manne look over contract with Ford to see if it is a "true lease' if it is continue on with deal. Give Rovazzi and Atty. Manne authority to move forward with truck bid process. Carried.

MOTION by Brewer, seconded by Rovazzi to accept procurement policy. Carried.

Mowers asked if agendas could be given to board members at least 3 days before board meeting to have time to review.

MOTION by Mowers, seconded by Bennett to approve the 2019 Organizational Meeting schedule with revisions. AYES Rovazzi, Brewer, Bennett, Geloso, Mowers. Carried.
