Meeting was called to order by Rovazzi at 2:00pm at the Town Community Center due to the Coronavirus . Pledge of Allegiance was said my all.

Rovazzi said revised budget has the following changes from Preliminary Budget. Increase of income by \$327.00 in fund 1081.0, account Other Payments in Lieu of Tax from \$16,000.00 to \$16,327.00 for the JGP and Ilion Housing Authority Pilot. Increase highway salary by \$1.75 per hour making it \$21.12 per hour for a 5 man crew and having only 1 part time worker for a period of 16 weeks for the winter months at \$20.00 per hour. Dutcher assured the board, all tasks will continue to be done with only a 5 man crew and 1 part timer (for winter).

The budget is now \$43.00 under the tax cap amount.

MOTION by Brewer, seconded by Hendrix to adopt the2021 budget as follows;

WHEREAS this board has met at the time and place as specified in the Legal Notice of a public hearing on the Preliminary Budget and heard all persons desiring to be heard:

THEREFORE be it resolved that this Town Board does hereby adopt such Preliminary Budget pursuant to Section 109 of the Town Law as changed, altered and revised as the Annual Budget of this Town of German Flatts for this Fiscal year beginning on the first day of January 2021 and that such 2021 budget as adopted be entered in the minutes of the Town Board, and be it

FURTHER RESOLVED that the Town Clerk prepare duplicate copies of said budget adopted pursuant of Section subd. 2 of the Town Law and deliver one copy to the Supervisor of the Town to be presented to the County Board of Legislators of this County.


