Increase revenue to\$143,359.00 from budgeted amount of \$143,289.00 in fund DB-3501.0 account St. Aid, Consolidated Highway.

Increase expenditures to \$54,299.00 from budgeted amount of \$54,229.00 in fund DB-9785.6 account Dept. Principle, Install Purch.

Formula was used to calculated increase in revenues to be in compliance with NYS Comptroller requirements.

Rovazzi ask if there were any question on proposed budget. No questions asked MOTION by Hendrix, seconded by Brewer to close public hearing at 6:16pm. Carried.

The date to adopt the 2021 budget was set for November 12, 2020 at 2:00pm, at the Town Community Center.

Rovazzi informed the board that he met with 5 members of the Canal Corporation to walk the trail between MOVAC and the Town Park to look at the damage along the trail. Canal Corp. will do an assessment on damaged trail and hopefully return with an answer to repair the trail in the spring. Rovazzi stated the Town may have to repair fence or install temporary fenching for the safety of the walkers before the Canal Corp. responds.
