FEMA Letter Regarding (NFIP) – Meeting was held with Rovazzi, Brewer & Klemik attending regarding letter received from FEMA. Rovazzi will reply to Scott Duell, Chief of Floodplain Management & Insurance with updates and ask for an extension. Mowers is afraid if this matter is not attended to ASAP Town could lose FEMA.

Manion Heights DOH Letter – Rovazzi has contacted several municipalities to find information on meter calibration, (cost and who can do this work) with no luck. Mowers will contact Mohawk Valley Water Authority. Fitzer will contact Rural Authority.

Budget Adjustment Transfer -

RAN Resolution -

MOTION by Brewer, seconded by Geloso to approve resolution to authorize and empower Supervisor of the Town of German Flatts to issue and sell, in the manner provided by the Local Finance Law, A Revenue Anticipation Note (RAN) in an amount not to exceed \$309,000.00. Said RAN is being authorized in furtherance of a RAN Resolution adopted by the Town Board of German Flatts on May 9, 2019. Ayes-4 Nays -0 Carried.

Budget Workshop - Mowers asked how sales tax was divided between the accounts. Sandedson answered was between B-General Town Outside and DB- Highway Part Town.

Mowers took charge by going over Tentative Town of German Flatts Budget line by line. Major question were, Town Clerk's Pers Serv budget line 1410.1 going from \$88,318.00 to \$50,349.00 – Cost of insurance and how to save money. Rovazzi gave some suggestions, Town Attorney single plan only, Town Board Members single plan only, Brewer added having employees contribute to the cost of their insurance and Geloso

wants to look at other insurance companies. - Donation of money to libraries and the need to have more money to cover potential legal fees.

Budget Workshop called to order by Supervisor Rovazzi at 1:00pm

Pledge of Allegiance said by all

All town employees were at the beginning of the meeting to discuss health insurance for the 2020 year. Cindy Bennett, JKB Benefits, Blue Cross/Blue Shield presented to the Board the proposed insurance premium for 2020 and discussed option that will keep the cost down.

Denny Mowers doesn't feel the employees should now pay part of the health insurance premiums. Andy Dutcher said he met with his crew over the budget and Andy stated if the employees didn't get a raise, then health insurance premiums shouldn't be paid for by his employees.

Denny Mowers stated the auditor's suggestions to save the Town money that we should look as a town to raise taxes, charge for health insurance.

Scott Hendrix discussed that all employees should absorb a minimal cost for health insurance; possible set a dollar amount rather than a percentage for health insurance coverage. Scott said everyone has to give a little. Scott asked how many employees currently pay for health insurance.

Judge Stone presented the Board and stated that the Court has applied for a \$30,000 grant to remodel the Court/Board Room to make the room more secure for the court files and also make the room more usable as a Board Room by changing the layout of the court bench. The bench will be used by the Board members during the Board meetings also.

Denny Mowers discussed the position in the Clerk's office that is on the proposed budge as a cut and asked Supervisor Rovazzi how he can decide what another department head needs.

Scott Hendrix asked the accountant and Supervisor how much income was generated by the London Bridge building and the Community Center and suggested that we sell the one of the properties if we don't make money from them.

RAN (Revenue Anticipation Note) Resolution:

Motion by Mowers, seconded by Brewer to approve resolution dated October 16, 2019, to authorize and empower Supervisor Rovazzi of the Town of German Flatts to issue and sell, in manner provided by the Local Finance law, a Renewal Revenue Anticipation Note of the Town in the amount not to exceed \$150,000, at such rate of interest as the said Supervisor of the Town shall prescribe. Said revenue Anticipation Note is being authorized in furtherance of a Revenue Anticipation Note Resolution adopted by the Town Council of the Town of German Flatts on August 28, 2013 and makes a \$25,000 interest payment due October 18, 2019 for the RAN (Revenue Anticipation Note)

Ayes-5 Nays-0

Budget Workshop – Supervisor Rovazzi reviewed with the Board an email he received from Hendrix relating to issues on the budget offering suggestions to help balance the budget. Hendrix also emailed the same suggestions to the Board members.

Supervisor Rovazzi and the Board went line by line to make any needed adjustments to the budget.

Mowers discussed not wanting to change the health insurance benefits for the employees. Mowers stated the Town employees aren't getting a raise so their health benefits should stay the same if at all possible. Mowers also discussed the clerk's office position and Clerk Madore stated that it was personnel issues which would need to be discussed with the department head in an executive session upon the return of Clerk Jones.

Hendrix discussed the two most expensive components for all employees is health care and benefits, stating we need to look at charging all employees for health insurance since the cost of health care has risen drastically. Hendrix discussed charging all employees a dollar amount for health insurance instead of a percentage.

Hendrix discussed reducing the insurance buyout from \$350.00 to \$250.00, putting the savings back into General Fund.

The next budget workshop will be held October 23, 2019 at 4:30pm with the regularly scheduled board meeting to follow at 5:30 at the Town Hall.
